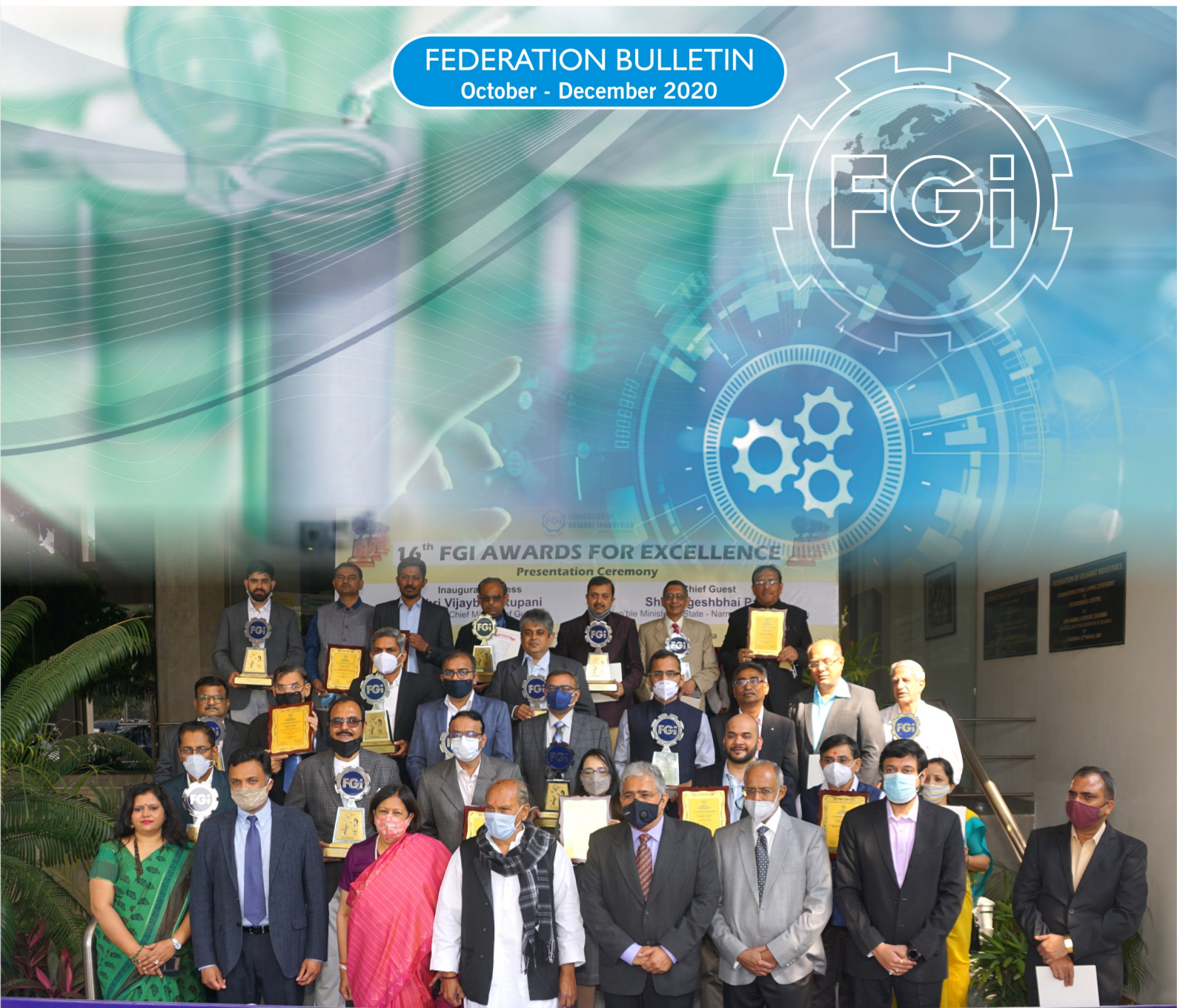

#### **Invitation received to join the Video Conference Chaired by Hon,ble MSME Commissioner Shri Ranjit Kumar J., IAS, from Joint Commissioner and General Manager, District Industries Center, Vadodara.**

Invitation was received to join the Video Conference Chaired by Hon'ble MSME Commissioner Shri Ranjit Kumar J., IAS, to discuss about establishing Technology Centre (TC) and Extension Centre (EC).

He requested the Associations to form a cluster and establish Technology & Extension Centre where the Association becomes the Nodal Office to take care and run the centers and later convert the same as profit centers. Its aim is to develop technologies and to share resources and to help with the MSMEs to avail the benefits of these centers. Association may get 100% funding from the Govt. to start the centers and more information will come in due course of time.

The Video conference was attended by Mr. Premal Dave, Secretary General, FGI.

### 8<sup>th</sup> October 2020

#### **Invitation for 4<sup>th</sup> Meeting (Virtual) of the FICCI Gujarat State Council**

FICCI - Gujarat State Council had organized a meeting with the members from the State to understand the challenges face by the industry post COVID-19 lockdown.

The interactive meeting was organized to share the details of the New Industry policy – 2020 recently launched by Government of Gujarat with Mr. M. K. Das, IAS, Additional Chief Secretary, Industries and Mines Department, Government of Gujarat. The highlights of the new Industrial Policy are as below:

Many new incentives and subsidies have been announced for industries in the Micro, Small and Medium (MSME) segment. Both capital as well as interest subsidies such as the following have been announced in order to boost MSME growth:

- Patent Support: 65% of rent upto INR 1 Lakh per annum for 3 years
- Technology Acquisition: Assistance to MSMEs to attend national and international exhibitions for 60% of stall rent upto a fixed amount
- Rent Assistance: 65% of rent upto INR 1 Lakh per annum for 3 years



- ICT Implementation: 65% of cost upto INR 1 Lakh for ERP and 65% of cost upto INR 5 Lakh for ICT implementation
- Power Connection charges: 35% of charges paid to distribution licences for LT/HT service line, upto INR 5 lakh
- Quality Certification: 50% of cost upto INR 10 lakh for obtaining certification and 50% of cost upto INR 50, 000 for ZED certification

The Gujarat Industrial Policy also identifies thrust sectors and core sectors, that the state considers a priority in terms of investment and manufacturing. Investors in these sectors shall receive focus and special incentives should they choose to manufacture products that fall under them.

The virtual meeting was attended by Mr. Manohar Chawla, President and Mr. Premal Dave, Secretary General, FGI.

### 28<sup>th</sup> October 2020

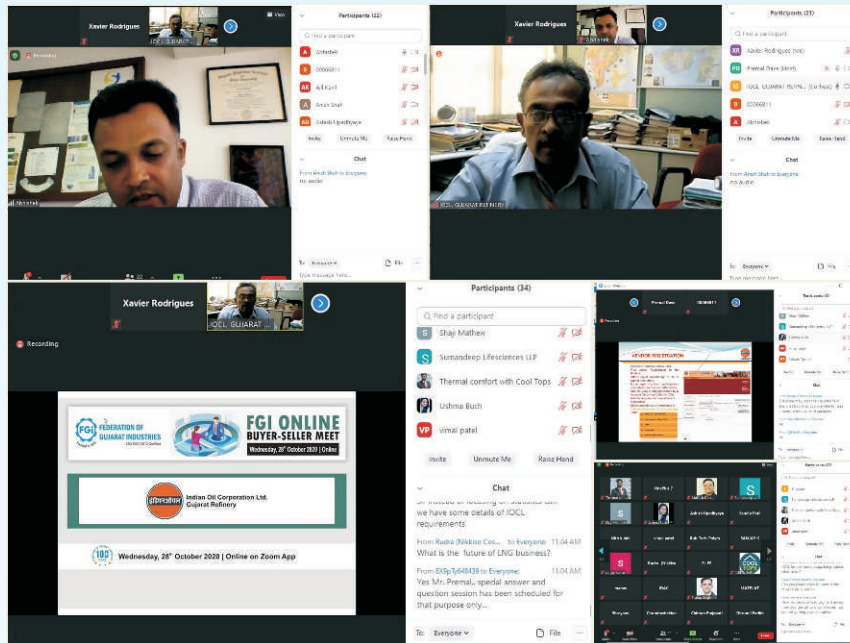
#### **FGI Online Buyer-Seller Meet (OBSM) 2020**

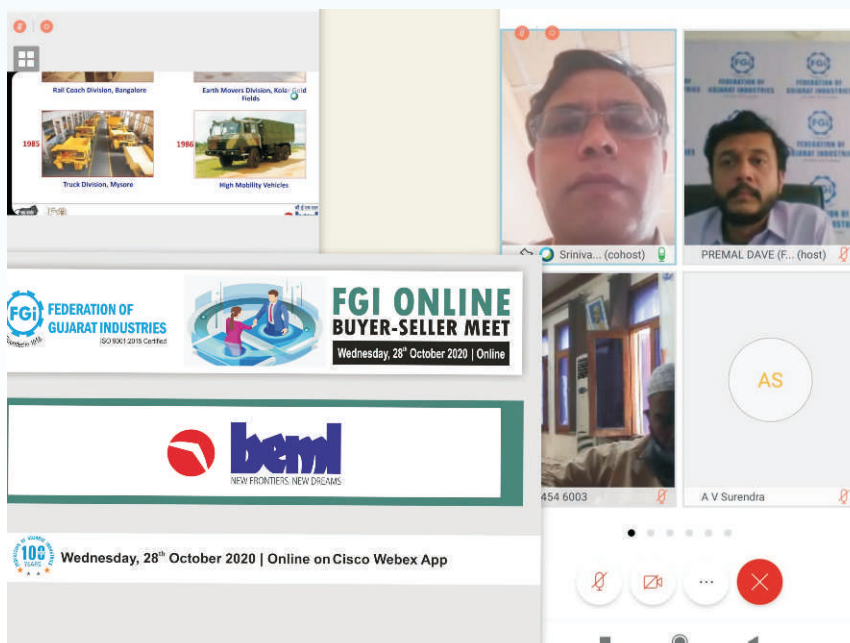
### OBSM with First PSU- Gujarat Refinery IOCL

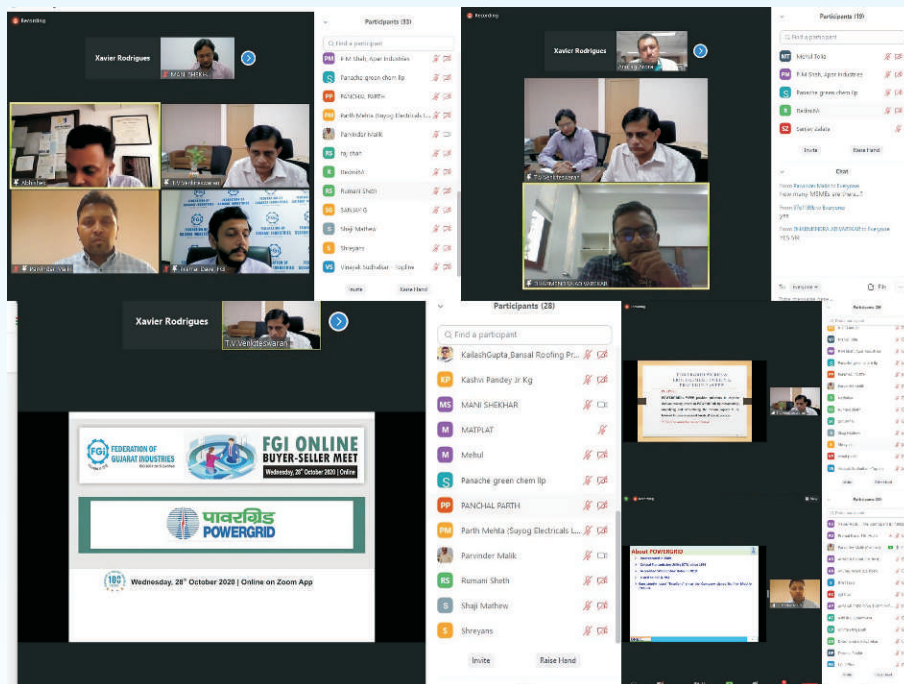
## OBSM with Third PSU - Power Grid Corporation of India Ltd.

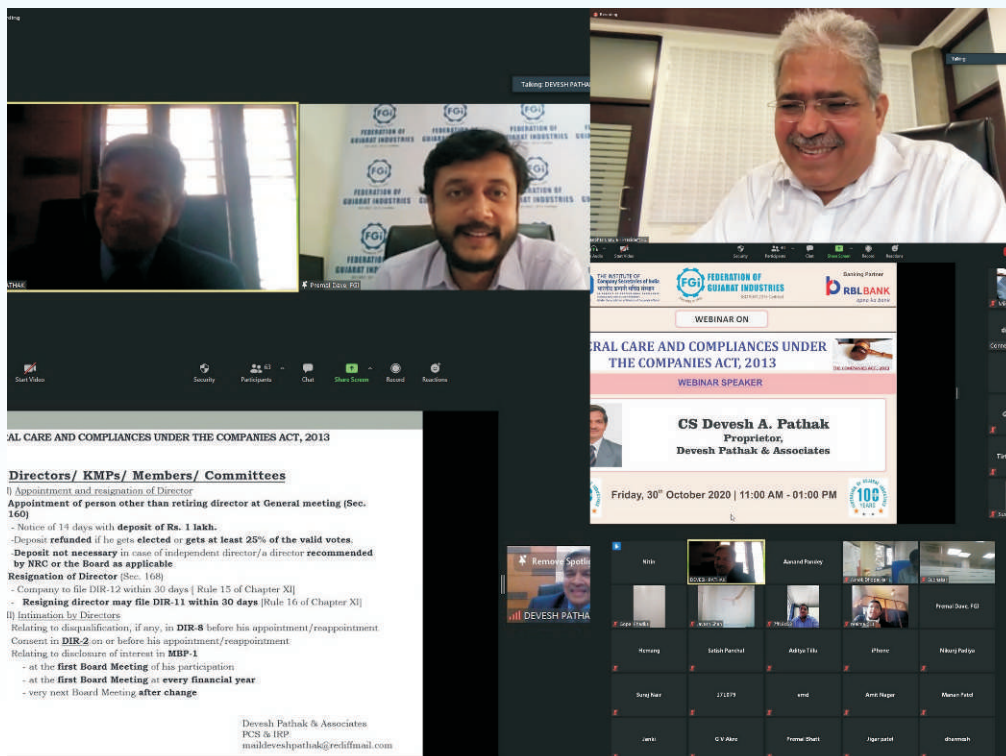

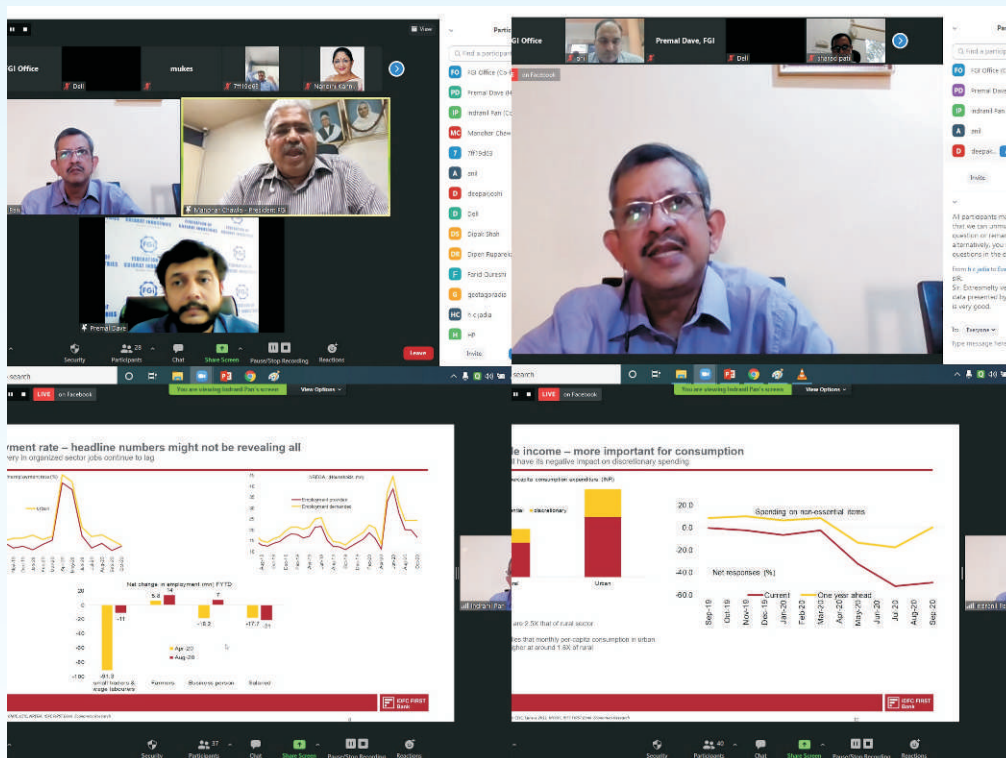
#### Webinar on Indian Economy with Mr. Indranil Pan, Chief Economist, IDFC First Bank Ltd.

#### Webinar on “Decoding the New Labour Codes”

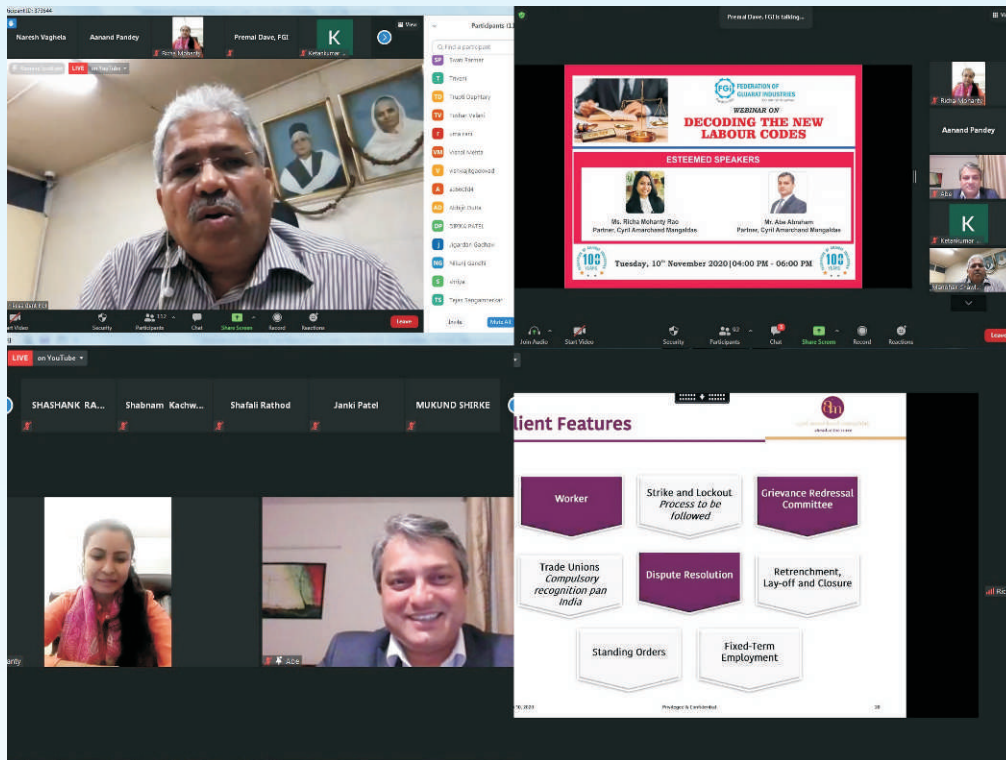

## 25<sup>th</sup> November 2020

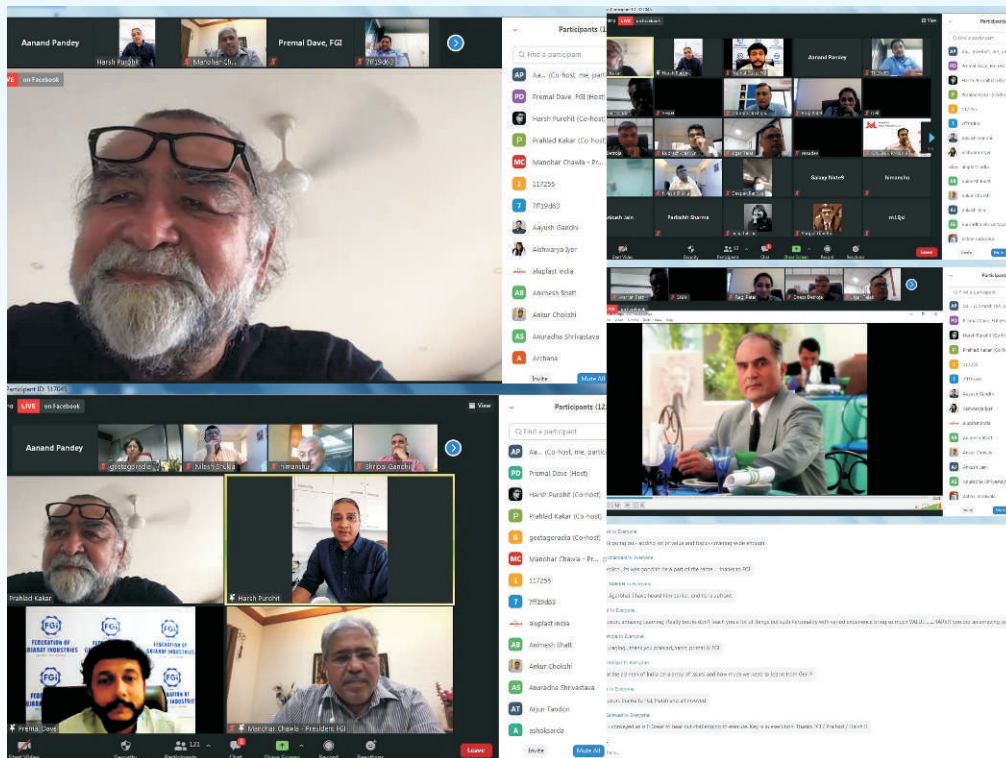
### Interactive Session on "The Future of the Future" with Mr. Prahlad Kakar

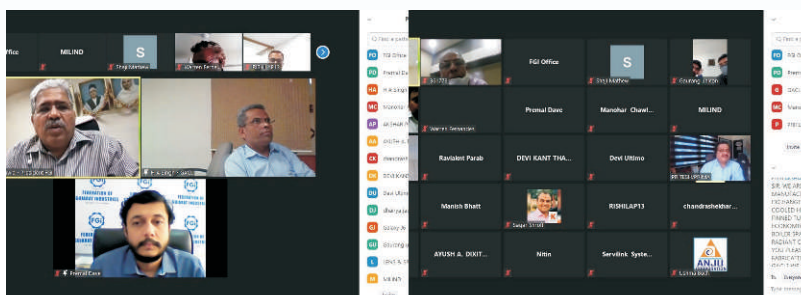
## OBSM with Second PSU - Gujarat Alkalies & Chemicals Ltd. (GACL)

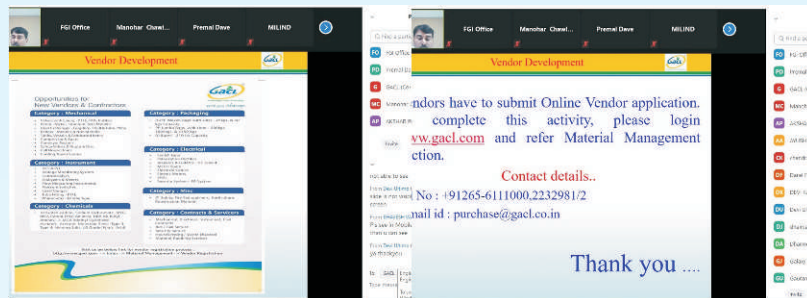

As large capital goods, plant and machineries that need to be capitalised requires capital build up period from 6 months to 24 months but due to COVID-19 many suppliers asked for extension in supply period in view of non-availability of resources.

In view of above, we made a request to the authority to consider the plea and grant extension of at least 1 to 2 years for those industries whose 3rd year is completed in financial year 2020-21.

## Webinar on ‘TDS & TCS - Changing Landscape’

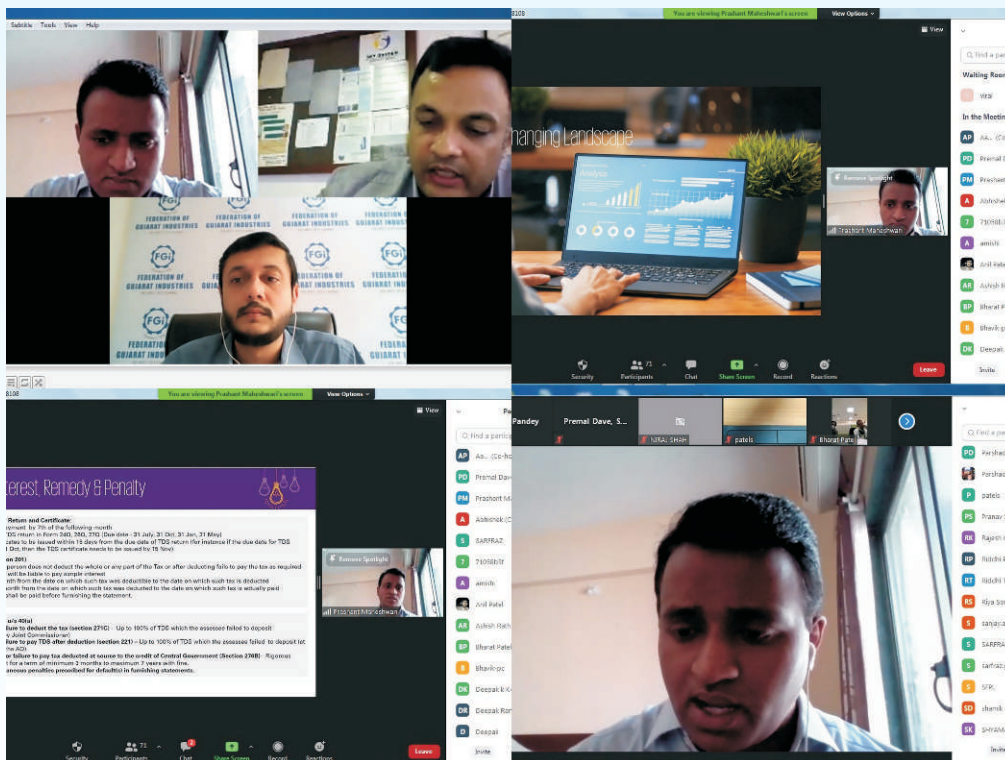

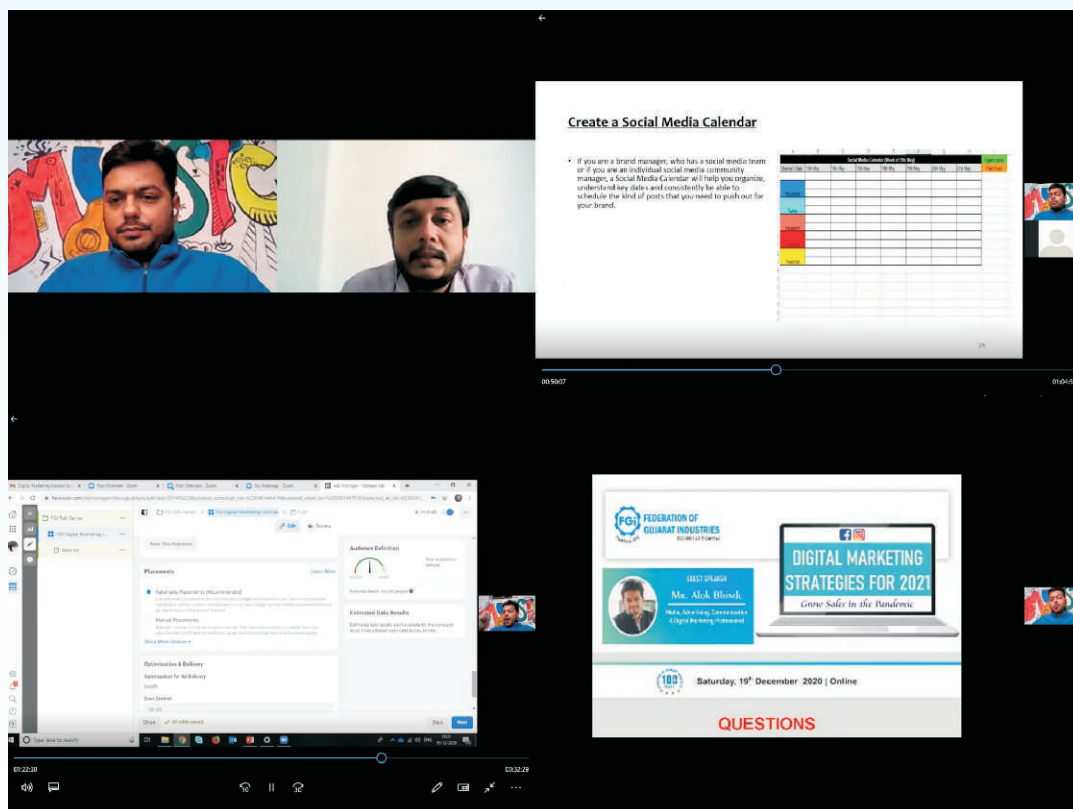
### Webinar on 'Digital Marketing Strategies for 2021'

### Webinar on 'E-Invoicing 2.0'

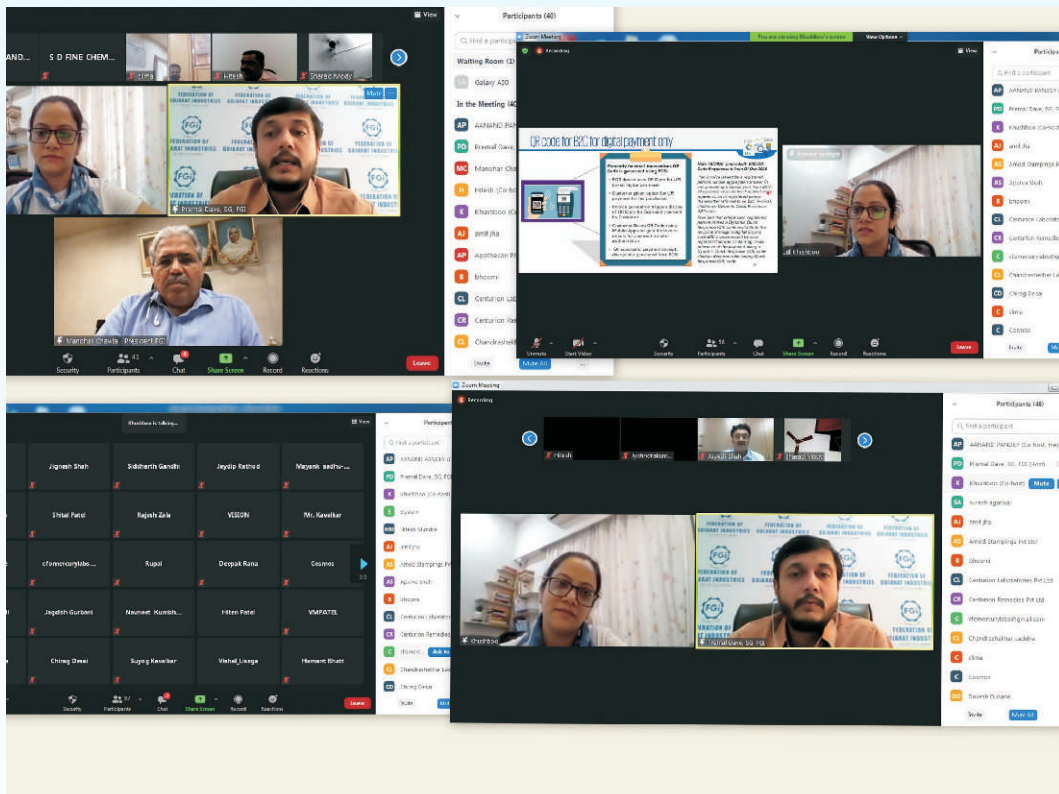
The webinar was conducted by Guest Speaker Ms. Khushboo Kundalia , Director – Indirect Tax, B S R & Associates LLP.

## Health & Wellness



### ALL YOU NEED TO KNOW ABOUT COVID – 19 VACCINE :

#### Will COVID-19 vaccine be given to everyone simultaneously?

Based on the potential availability of vaccines the Government of India has selected the priority groups who will be vaccinated on priority as they are at higher risk.

The first group includes healthcare and frontline workers. The second group to receive COVID-19 vaccine will be persons over 50 years of age and persons under 50 years with comorbid conditions.

#### Is it mandatory to take the vaccine?

Vaccination for COVID-19 is voluntary. However, it is advisable to receive the complete schedule of COVID-19 vaccine for protecting one-self against this disease and also to limit the spread of this disease to the close contacts including family members, friends, relatives and co-workers.

#### Will the vaccine be safe as it is being tested and introduced in a short span of time?

Vaccines will be introduced in the country only after the regulatory bodies clear it based on its safety and efficacy.

#### Can a person presently having COVID-19 (confirmed or suspected) infection be vaccinated?

Person with confirmed or suspected COVID-19 infection may increase the risk of spreading the same to others at vaccination site. For this reason, infected individuals should defer vaccination for 14 days after symptoms resolution.

#### Is it necessary for a COVID recovered person to take the vaccine?

Yes, it is advisable to receive complete schedule of COVID vaccine irrespective of past history of infection with COVID-19. This will help in developing a strong immune response against the disease.

#### Out of the multiple vaccines available, how is one or more vaccine chosen for administration?

The safety and efficacy data from clinical trials of vaccine candidates are examined by Drug regulator of our country before granting the license for the same. Hence, all the COVID-19 vaccines that receive license will have comparable safety and efficacy.

However, it must be ensured that the entire schedule of vaccination is completed by only one type of vaccine as different COVID-19 vaccines are not interchangeable.

#### Does India have the capacity to store the COVID vaccine at temperature of +2 to +8 degree Celsius and transport them at required temperature?

India runs one of the largest Immunization programme in the world, catering to the vaccination needs of more than 26 million newborns and 29 million pregnant women. The programme mechanisms are being strengthened / geared up to effectively cater to the country's large and diverse population.



**Will the vaccine introduced in India be as effective as the ones introduced in other countries?**

Yes. The COVID 19 vaccine introduced in India will be as effective as any vaccine developed by other countries. Various phases of vaccine trials are undertaken to ensure its safety and efficacy.

**How will I know if I am eligible for vaccination?**

In the initial phase, COVID 19 vaccine will be provided to the priority group- Health Care and Front-line workers.

The 50 plus age group may also begin early based on vaccine availability. The eligible beneficiaries will be informed through their registered mobile number regarding the Health Facility where the vaccination will be provided and the scheduled time for the same. This will be done to avoid any inconvenience in registration and vaccination of beneficiaries.

**Can a person get the COVID-19 vaccine without registration with Health Department?**

No, registration of beneficiary is mandatory for vaccination for COVID 19. Only after registration the information on the session site to visit and time will be shared with the beneficiary.

**What documents are required for registration of eligible beneficiary?**

Any of the below mentioned ID with Photo may be produced at the time of registration:

- Aadhar Card
- Driving License
- Health Insurance Smart Card issued under the scheme of Ministry of Labour
- Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA)
- Job Card
- Official identity cards issued to MPs/MLAs/MLCs

- PAN Card
- Passbooks issued by Bank/Post Office
- Passport
- Pension Document
- Service Identity Card with photograph issued to employees by Central/ State Govt./ PSUs/Public Limited Companies
- Voter ID
- Smart card issued by RGI under NPR

**Will a Photo / ID be required at the time of registration?**

The Photo ID produced at the time of registration must be produced and verified at the time of vaccination.

**If a person is not able to produce Photo ID at the session site, whether s/he be vaccinated or not?**

Photo ID is a must for both registration and verification of beneficiary at session site to ensure that the intended person is vaccinated.

**How will the beneficiary receive information about due date of vaccination?**

Following online registration, beneficiary will receive SMS on their registered mobile number on the due date, place and time of vaccination.

**Will vaccinated beneficiaries receive information on the status of their vaccination after completion?**

Yes. On getting due dose of COVID 19 vaccine, the beneficiary will receive SMS on their registered mobile number. After all doses of vaccine are administered, a QR code based certificate will also be sent to the registered mobile number of the beneficiary.

**If one is taking medicines for illnesses like Cancer, Diabetes, Hypertension etc, can s/he take the COVID- 19 vaccine?**

Yes. Persons with one or more of these comorbid conditions are considered high risk

category. They need to get COVID-19 vaccination.

**Are there any preventive measures and precautions that one needs to follow at the session site?**

We request you to rest at the vaccination centre for at least half an hour after taking the COVID-19 vaccine. Inform the nearest health authorities / ANM / ASHA in case you feel any discomfort or uneasiness subsequently.

Remember to continue following key COVID Appropriate Behaviours like wearing of mask, maintaining hand sanitization and physical distance (or 6 feet or Do Gaj).

**What about the possible side-effects from COVID-19 vaccine?**

COVID Vaccine will be introduced only when the safety is proven. As is true for other vaccines, the common side effects in some individuals could be mild fever, pain, etc. at the site of injection.

States have been asked to start making arrangements to deal with any Covid-19 vaccine-related side-effects as one of the measures towards safe vaccine delivery among masses.

**How many doses of the vaccine would have to be taken by me and at what interval?**

Two doses of vaccine, 28 days apart, need to be taken by an individual to complete the vaccination schedule.

**When would antibodies develop? After taking first dose, after taking second dose, or much later?**

Protective levels of antibodies are generally developed two weeks after receiving the 2<sup>nd</sup> dose of COVID-19 vaccine.
