ANNEXURE - 'C'

ARTICLE (9) NOMINEES OF MEMBERS :

9.01 PRINCIPAL NOMINEE :

- (i) (a) In respect of a member being a Private or a Public Limited Company with its registered office or head office situated in the State of Gujarat the managing Director or a whole time Director who is a member of the Board Director or
(b) A functional head who directly report to the Managing Director of a Company which has a turnover net of excise & sales tax exceeding Rs. 50 crores, provided that such a functional head is empowered by a resolution of the Board Directors of his Company, to take decision for and on behalf of his Company at the deliberations of the federation so as to commit his company to such decisions.
- (ii) In respect of a member being a Private or a Public Limited Company whose registered office or head office is situated outside the State of Gujarat, and whose production/marketing and service unit is located in the State of Gujarat, the Chief Executive of the said unit by whatsoever designation described and duly authorized by a board resolution to take all decisions on behalf of such member Company, provided that the Managing Director or a Whole time Director does not normally reside in the State of Gujarat.
- (iii) In respect of a member being other than a Private or Public Limited Company :
(a) A partner of a Firm. (b) The Proprietor of a Concern. (c) The Chairman or the Managing Director or the functional head known by whatever name and designation of a Cooperative Society. (d) The individual Associate Member. (e) The President of the Association & Institutional member.

9.02 ALTERNATE NOMINEE :

An Ordinary Member will be allowed to nominate an Alternate Nominee and such nominee will be entitled to participate and to vote at the Annual General Meeting in absence of the Principal Nominee.
