About the Food Park:

Gujarat Agro Infrastructure Mega Food Park is the first Mega Food Park in Gujarat and is located at Village Shah and Vasravi, Taluka Mangrol, District Surat. It was inaugurated in 2018 by the then Hon'ble Union Minister for Food Processing Industries Smt Harsimrat Kaur Badal. **The food park is promoted by Urja Group, Adani Wilmar Ltd and other promoters.**

This Mega Food Park has been set up in 70.15 acre of land at a cost of Rs. 117.87 crores under a special initiative of Government of India's Ministry of Food Processing Industries (MOFPI) with a Cluster Development Approach. The food park aims on adding value and reducing food wastage at each stage of the supply chain with particular focus on perishables. It is immensely benefiting the farmers, growers, processors and consumers of Gujarat and adjoining areas and providing a big boost to the growth of the food processing sector in the State of Gujarat.



Gujarat Agro Infrastructure Mega Food Park is best suited for Units to expand into the Food Processing Business and provides the following benefits:

- Excellent location in terms of Production & Processing.
- Logistics and fulfilment centre to serve key markets.
