MINUTES OF THE 102nd ANNUAL GENERAL MEETING OF THE FEDERATION OF GUJARAT INDUSTRIES HELD ON FRIDAY, 9th OCTOBER 2020 AT 11:00 A.M. ONLNE ON ZOOM APP

Mr. Manohar Chawla, President, FGI, welcomed all the members present at the 102nd Annual General Meeting of FGI (Annexure I). As the number of members present constituted quorum, he called the meeting to order.

The President then took up the items on the agenda as follows:

- I. The minutes of the last Annual General Meeting held on 27th September 2019 and circulated on 1st November 2019 vide letter no. FGI/AGM/ 045 dated 22nd October 2019 were put up to the house for confirmation. As there were no objections, the President declared the minutes as duly confirmed.
- II. The President made a small presentation, referring to the Annual activities of the Federation for the year 2019 -2020, mentioned that the Annual-Report had been circulated to the members in advance. CA Sanjeev Shah & Mr. Sameer Khera, Managing Committee Members, FGI seconded the Resolution.

The above Resolution was passed unanimously by the members present.

V. Appreciating various activities undertaken by the Federation, the members of the house thanked the President and his team for putting sincere efforts in carrying out the FGI activities successfully throughout the year.

As all the items on the agenda had been dealt with, the President declared the meeting as concluded.
